**“Privilege of the floor”**

Marie Lusins addressed the board and issued the following statement:

I have been associated with Job Corps (JC) for over 30 years. Initially, I was appointed as liaison while serving as a Councilman on the Oneonta Town Board. Then as President and District Governor of the Oneonta Rotary club. I worked with Directors of JC on a number of grant projects.

We depended on JC to provide the ground work and paving plus installation for Accessible Playgrounds for Oneonta Elementary Schools before the state and federal guidelines for disabled children. JC has provided crossing guards for children after school on state streets and in our parks where needed.

Habitat for Humanity has depended on their skilled work for foundations for the various homes that have been built.

Rotary commenced on a book project collecting used children’s books for Head Start. We asked JC to build 80 plus bookcases. Each Head Start child’s family received a bookcase filled with books suitable for children 5-9 years old. Our JC received national recognition.

I have visited JC and have seen their outstanding programs, such as the Line and Electrical program. The Drone program is unique and its graduates are highly sought after. The Nursing program students working with Bassett fulfill our community’s need for caregivers.

It’s difficult for me to think that these students will lose their chance for a better future. I realize the cost factor to the taxpayers and federal government, however, (to be corny) I think of the story of the starfish washed up from the sea. I believe we have a chance to continue to make a difference in these young peoples lives. Let me state once again, Oneonta is a unique place to live... it is a Kind place.

Andrea Lister, resident of West End in the town of Oneonta; raised concerns about the increasing number of seasonal rentals and their impact on neighborhoods. Further stating the loss of homes to seasonal rentals is affecting the local community and driving up housing prices. A suggestion was made to establish a task force to explore density regulations for seasonal rentals.

Member Fierke reminded all that a Community Ad Hoc Committee is in the formative stages and will be addressing these issues.

The committee will include planning board members and community representatives. Discussions will also include accessory dwelling units

and short-term rental regulations.

Kevin James requested permission of the board to conduct an event at Fortin Park focused on and around HAM Radio Field Days, a global event for HAM radio operators, to be held over the weekend of June 27, 2025. The event would involve radio operations and public demonstrations. The club sought a waiver for overnight use of the park and requested access to electricity, which was duly granted by the board.

Tirusha Dave & Prashanth Gorantala with EcoYotta, Inc.; seeking a zone change for parcel#298.00-2-15.02, 357 County Highway 9, from RA40 to IDD, to develop the property as a research center. PRK wanted to reiterate that she voted no to refer this to the Planning Board because she was not interested in rezoning Residential Agricultural land for any type of potential Industrial activity. The rezoned designation would forever be attached to the parcel. PRK said there are other locations in the Town with appropriate zoning and infrastructure where this proposed project would likely be welcomed.

Neighbors voiced concerns about potential noise pollution, water usage, and the impact on the neighborhood's character.

**RESOLUTION 2025-0068 SCHEDULING PUBLIC HEARING PERTAINING TO THE PROPOSED FORMATION OF THE TOWN OF ONENONTA WEST END WATER DISTRICT PURSUANT TO ARTICLE 12-A, SECTION 209-d OF THE TOWN LAW OF THE STATE OF NEW YORK**

WHEREAS, the Town Board for the Town of Oneonta, is considering the formation of a water district in the Town of Oneonta to be known as the West End Water District; and

WHEREAS, the Town Board believes it in the best interest of the citizens of the Town to form a water district, said proposed water distribution system to include the areas described in Schedule A attached hereto and made a part hereof; and

WHEREAS, to further consider a proposed water district to be known as the West End Water District, and pursuant to Article 12-A of the Town Law of the State of New York, the Town Board, directed C&S Engineers Inc. of 499 Col. Eileen Collins Blvd, Syracuse, New York 13212, to prepare a Map, Plan and Report of the proposed water district; and

WHEREAS, said Map, Plan and Report was filed with the Town Clerk for the Town of Oneonta the May 12<sup>th</sup>, 2025, entitled West End Water District, Map, Plan and Report, October 2024; and

WHEREAS, this Board has reviewed the Map, Plan and Report, and wishes to schedule a public hearing regarding the possible formation of a water improvement district to be known as the West End Water District pursuant to Article 12-A Section 209-d of the Town Law of the State of New York.

NOW, THEREFORE, on motion made by Council Member Patricia Riddell Kent, and seconded by Council Member Josph M. Camarata;

BE IT RESOLVED as follows:

1. That this Board will hold a Public Hearing pursuant to Section 209-d of the Town Law of the State of New York on the 11th day of June, 2025 at 7 p.m. at the Town Hall, 3966 State Highway 23, West Oneonta, NY 13861 to consider the formation of a water district to be known as the West End Water District, and directs that notice of same be given pursuant to law.

2. That pertaining to the proposed water district, the Town Board does hereby find as follows:

a. A description of the boundaries of the proposed water district is more particularly set forth in Schedule A attached hereto and made a part hereof.

b. The improvements proposed would be as follows:

The City of Oneonta has an established water system serving the proposed West End Water District. The West End Water District will continue to utilize the existing facilities in the Town of Oneonta. The existing facilities are as follows:

- Seven (7) interconnections with the City water system;
- Ninety-Seven (97) fire hydrants;
- Two hundred and Twenty-Six (226) main line valves;
- 37,580 linear feet of existing 6" (CIP and DIP) water main;
- 21,042 linear feet of existing 8" (CIP and DIP) water main;
- 1,214 linear feet of existing 10" (CIP and DIP) water main;
- 11,120 linear feet of existing 12" (CIP and DIP) water main;
- Six Hundred and Fifty-Six (656) water services; and
- One (1) 500,000-gallon water tank.

d. Financing for the proposed project is not necessary as the district will utilize existing facilities. There are no new facilities planned to be constructed at this time. As a result, there is no new capital cost associated with the proposed West End District.

The resulting initial annual unit charge is estimated to be \$556.23 per equivalent dwelling unit (EDU). This charge represents the total annual cost to a typical single-family household, inclusive of water purchase.

e. The Map, Plan and Report describing such improvements as prepared C&S Engineers Inc., and filed in the Town Clerk's Office of the Town of Oneonta, is available for public inspection.

3. That the Town Clerk of the Town of Oneonta is hereby authorized and directed to publish a copy of this Resolution/Order in the Daily Star, the official newspaper for the Town of Oneonta, and to post a copy of same on the official bulletin board for the Town of Oneonta in the time and manner required by law.

#### West End Water District Formation

- A proposal was made to form the West End Water District Number 1 to facilitate water bill collection.
- The city would handle billing and maintenance of the water infrastructure.
- The formation of the district would not result in additional costs for town homeowners.
