Others present: Rob Panasci, Town Attorney; James Hurtubise, Highway Supt.; Deyanira Cisneras; Linda Wegner; Steve Kent; Arley Lau; and Michael Schmitt.

PETITIONERS

Deyanira Cisneros and Linda Wegner of 'Advancing Tobacco-Free Communities' gave a presentation on promoting tobacco-free communities and urged the town to adopt a 'Tobacco-Free Policy. They said the current initiative is targeting public parks, playgrounds, recreation areas and events. Smoking remains the number one cause of preventable death and disability in the United States they said. They said the program would provide a certain number of signs for the town's Fortin Park, once the town adopts a new Tobacco-Free Policy. Supervisor Wood said the town has previously adopted a 'Smoke-free' policy, but it does not cover all tobacco uses such as 'vape' and 'chew'. He added that enforcement can be an issue.

COMMITTEE REPORTS

Highway/Water & Sewer - Councilwoman Riddell Kent gave the following report and recommendations:

Surplus 2007 Dodge Durango – Motion was made by Mowers, seconded by Holleran to surplus the 2007 Dodge Durango.

Westgate Project payment – Motion was made by Riddell Kent, seconded by Jacob to approve Delaware Bulldozing Corporation's application for payment #1 in the amount of \$87,813.25 (keeping the retainage of \$4,621.75).

Public Safety – Supervisor Wood reported as follows:

Unsafe properties –

14 Jackson Ave. – Supervisor Wood said the County Treasurer supports taking over this property and ultimately turning over to the land bank.

238 West St – Code Officer Neske has inspected the property, taken pictures, and noted that Mr. Mulholland has made progress. Mulholland is asking a relative to assist with the repair of the foundation.

1031 Swart Hollow Road – Code Officer Neske has taken pictures at 15 day intervals and noted that there has been substantial improvement.

115 Valley St. – Supervisor Wood will try to connect with the owners of this property.

Councilman Mowers suggested that the old Ford Explorer could be used as a speed decoy on Winney Hill Road and Old Southside Drive.

The Town Board agreed to have Supervisor Wood send a letter to the President of Xpress Natural Gas Co. (XNG) supporting the Otsego County Board of Public Safety and Legal Affairs Committee and Senator Seward request to reroute their trucks to the Interstate Highway.

Facilities, Technology, Parks - Councilman Holleran had nothing to report.

Human Resources and Public Benefit –

New Sexual Harassment Policy – Attorney Panasci suggested that the Legislative Committee review this policy before the Town Board acts on it.

Legislative – Councilwoman Jacob said she’s been working an amendment to the zoning law that would require a public hearing for certain site plan reviews.

ATTORNEY

Attorney Panasci updated the board regarding the Article 78 Proceeding that he filed against the Town of Oneonta Fire District. In that ‘Proceeding’ he asked the judge for a ‘temporary restraining order’ that will force the fire district to continue to operate as a fire district until this case is resolved. The court hearing is scheduled for October 18th at 1:30pm to discuss the continuation of the ‘temporary restraining order’. He asked Terrance Hannigan, the Fire District attorney numerous times if they would agree to dissolve at a later date so the town wouldn’t have to bring this lawsuit. He didn’t and hasn’t responded. Mr. Hannigan plans to bring a motion to dismiss because the Town does not have standing to bring the lawsuit, meaning the town will not be ‘injured’ by this matter. Panasci said this is just one more thing that shows they are not willing to work with the town.

Councilman Mowers said: “Not injured? Yes we are! We’re spending taxpayers money to sue ourselves...it’s ridiculous!”

Councilman Holleran said: They are ‘injuring’ us by shorting us \$700,000 in the 2019 budget.
