Resolution

WHEREAS, for the past 45 years, the Oneonta Job Corps Academy has been a valued neighbor and a partner in the betterment of our city; and

WHEREAS, the Oneonta Job Corps Academy, has made countless community projects possible through its regular donation of student production and its instructors' expertise and oversight; and

WHEREAS, in 2024 (per its own budget) the Academy had an economic impact on the community of \$22,937,132; and

WHEREAS, as an employment and training program, the Oneonta Job Corps Academy has had significant, documented, and life changing success, with a graduation rate that exceeds many community colleges, and a career placement rate which ranks 32nd among all the centers in the country; and

WHEREAS, the loss of the Oneonta Job Corps Academy would have a deleterious effect on our economy, our infrastructure, the capacity of our community services, and the quality of life in the Town; and

WHEREAS, the closure of the Oneonta Job Corps Academy would be the retraction of a helping hand, and of the opportunity for hundreds of young men and women to pull themselves from poverty and place themselves on the very ladder of success that is the American Dream, in many cases providing precedent and role modeling to family, friends, and neighborhoods.

Therefore, IT IS HEREBY RESOLVED that the Town of Oneonta stands in vigorous opposition to the potential closure of the Oneonta Job Corps Academy, advises all decision-making members of government to take note, and implores their support of this institution and its long-term future.
