RESOLUTION ADOPTING THE 2027 PUBLIC BUDGET SCHEDULE

At a regular meeting of the Town Board of the Town of Oneonta, held at Town Hall, 3966 State Highway 23, West Oneonta, New York, on August 12, 2026, the following resolution was offered and seconded:

WHEREAS, the Town Board seeks to provide an orderly, transparent and publicly accessible process for the preparation and review of the Town's 2027 annual budget; and

WHEREAS, the proposed 2027 Public Budget Schedule provides for public workshops, presentation and review of the tentative budget, a public hearing on the preliminary budget, and consideration of final adoption before the statutory deadline;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby adopts the Town of Oneonta 2027 Public Budget Schedule attached to this resolution; and

BE IT FURTHER RESOLVED, that the schedule is intended to support the responsibilities assigned by law to the Budget Officer, Town Clerk, Supervisor, Town Board and Town officials and shall not alter their respective statutory authority or duties; and

BE IT FURTHER RESOLVED, that the Town Clerk is directed to post the adopted schedule on the Town website and provide all separate meeting and public-hearing notices required by law.

**TOWN OF ONEONTA
2027 PUBLIC BUDGET SCHEDULE**

August 12, 2026

The Town Board will announce the start of the 2027 budget process and adopt the public budget calendar.

September 16, 2026

The Town Board will hold its first public budget workshop to review the Town's financial condition, current-year projections, service needs, preliminary revenue assumptions, reserves, capital needs and major budget priorities.

September 30, 2026

The Budget Officer will file the tentative budget with the Town Clerk in accordance with Town Law.

October 5, 2026

The tentative budget will be formally presented to the Town Board at a special meeting and made available to the public.

October 8, 2026

The Town Board will hold a second public budget workshop for detailed review of the tentative budget.

October 14, 2026

The Town Board will complete its review of proposed changes and establish the preliminary budget for public hearing.

October 29, 2026

The Town Board will hold the official public hearing on the preliminary budget. Members of the public may comment on the proposed budget or any item contained within it.

November 12, 2026

At a special Town Board meeting, the Board will consider final revisions and adoption of the 2027 Town budget.

The 2027 Town budget must be adopted no later than November 20, 2026.

Budget documents, meeting notices, agendas and information on submitting written comments will be posted on the Town website as they become available.
