Chairman Camarata opened the meeting and asked if there was anyone in attendance to speak for or against the Special Use Permit for a short term rental. Thomas Falco was present and the notifications were verified. Several neighbors were in attendance and spoke, while not all necessarily were for or against the application, have some concerns with the increased traffic, lack of traffic signs and parties. John Frisch requested to go on record that he was dead set against this and believes the quality of living has gone down with baseball broadcasts, not being able to go to sleep until after the fireworks on Thursdays, strangers in community and now the fire whistle. The creek was brought up, but that is a homeowner issue. Kirt Mykytyn offered that Mr. Falco may possibly want to post information for tenants regarding creek.

Motion made by Kirt Mykytyn and seconded by Tom Rowe to close the public hearing.

Chairman Camarata advised it is an allowable use in the Town and if concerned they would need to pursue with the Town Board regarding the code. If issues arise neighbors are encouraged to contact owner (Thomas Falco), Constable, Code Enforcement Office, Sherriff, and/or State Police. The permit issued is for one year and at time of renewal, should there be no complaints it would be renewed subject to the annual required Fire Inspection from the code office. If there were complaints, the applicant may have to appear before the board before renewal. The board added there have been minimal complaints. The rentals are for one family only, as Town Code states there can be no more than 2 unrelated individuals residing in a dwelling unit and there is noise ordinance(10PM). Chairman Camarata assured that the board shared their concerns and that he would be in touch with Highway Supervisor James Hurtubise, regarding speed limit signage, "STOP" Sign and possibility of a "Children at Play" sign.

Motion made by Kirt Mykytyn and seconded by Breck Tarbell that the Special Use Application for a short term rental will not have a negative impact on the environment.
